

Brookfield REIT Leases Out 1m sq ft of Space in Q3

REIT has given a guidance of 2-2.4 m sq ft of new leasing for the next 4-5 quarters

Mumbai: Brookfield India Real Estate Trust has leased more than 1 million square feet office space to Accenture, Capgemini, L&T Hydrocarbons, Newgen, Wipro, and Genpact in the quarter ended December. The REIT has also provided guidance of 2.0-2.4 million square feet new leasing for the next 4-5 quarters.

Of the total deals, new leasing is around 500,000 square feet including 400,000 square feet in its Special Economic Zone (SEZ) assets, the highest ever since the REIT's listing in November 2019. The quarter leasing sequentially outperforms the previous best quarter of July-September by over 22%.

Lease renewals by occupiers including Deloitte and Evalueserve for 233,000 square feet and 232,000 square feet, respectively, totalled 539,000 square feet during the quarter.

The REIT has applied for conversion of 1 million square feet of commercial office spaces in the Mumbai Central business area across its operational portfolio of 20.7 million square feet. The proposed denotification of 1 million square feet is part of the total 3.3 million square feet space to be completed by year-end.

"Increased demand for Grade A office assets has resulted in gross leasing surpassing 1 million square feet for the quarter, including a record quarterly new leasing of 5 million square feet," says IPO assets witness. "Strong traction with end-user leasing demand from global capability centres of large corporates and technology companies," said Alok Aggarwal, CEO of Brookfield India Real Estate Trust.

He expects the recently announced reforms to further boost the demand for SEZ assets and has applied for conversion of 1 million square feet into non-processing area across the company's portfolio.

"With a favourable leasing outlook and limited term expires over the next four quarters, we foresee substantial occupancy improvement throughout 2024," Aggarwal added.

SC Allows IOC, ArcelorMittal to Solve Dispute via Arbitration

The parties have agreed to nominate two arbitrators within a week: SC Bench

New Delhi: The Supreme Court's decision on Monday set aside Delhi High Court's stay on the appointment of an arbitral tribunal to settle its ₹6,772-crore claim against ArcelorMittal Nippon Steel India, saying the two companies have mutually agreed to nominate two arbitrators within a week.

In October last year, the high court had termed the disputes as "non-arbitrable" and held that "no reference to arbitration tribunal is warranted".

Public-sector undertaking IOC had initially filed the suit against steel major Essar Steel India, which was taken over by Lakshmi Mittal-led ArcelorMittal in December 2019 after it won approval from the Supreme Court.

A bench led by Chief Justice D.Y. Chandrachud noted at the start of both the sides that there is an agreement between IOC and ArcelorMittal regarding appointment of their respective arbitrators. "The parties have agreed to nominate two arbitrators within a week. The two arbitrators so appointed will nominate the third arbitrator in view of the agreement of the parties," said the HC's October 10 judgment is rendered in infractions, it said, adding that all right-and contentious of the parties are kept open.

The top court had, last week, reserved its judgment on IOC's appeal, but later the parties had agreed against passing the judgment in their case.
